Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN

Purchase does not increase chance of winning.

Subject to any governmental approval that may be required, Sponsor reserves the right to, without prior notice and at any time, terminate the contest, in whole or in part, or modify contest in any way, should any factor interfere with its proper conduct as contemplated by these Official Rules. Contest will begin on December 1, 2018 at 12:00 a.m. EST and will continue until January

- 15, 2019 at 11:59 p.m. EST. Sponsor reserves the right in its sole discretion, to cancel the contest in its entirety, or only the online portion, if it becomes technically corrupted or because of non-authorized human intervention.
- 3. **Eligibility.** Must be at least 18 years old to enter. No purchase necessary. A purchase does not enhance your chance of winning.
- 4. **Effective date of entries.** Entries made online will be effective on the day received. Entries submitted by mail will be effective on the date Sponsor receives and processes the entry.
